**UNIDATA S.p.A. - CHANGE IN THE FINANCIAL CALENDAR 2021
FOLLOWING THE POSTPONEMENT OF TODAY'S BOARD MEETING TO APRIL 14, 2021**

Rome, March 29, 2021 - Unidata S.p.A., operator of Telecommunications, Cloud and IoT services, listed on the AIM Italia market of Borsa Italiana, announces that the Board of Directors meeting scheduled today for the approval of the draft consolidated financial statements and the financial statements as of December 31, 2020 of Unidata S.p.A. has been postponed to April 14, 2021 in relation to the time required by the technical complexity due to the adoption of the new IAS/IFRS international accounting standards.

The transition, assigned to the Company's Administrative Offices, from the system historically adopted by the Company based on Italian accounting standards to the adoption of the new IAS/IFRS international accounting standards (applied for the first time by the Company) is causing a lengthening of the time required in order to complete the complex transition to a technically correct manner.

Therefore, the new meeting of the Board of Directors to approve the draft consolidated financial statements and the financial statements for the year ended December 31, 2020 of Unidata S.p.A. is postponed to April 14, 2021.

Below are the new rescheduled dates:

- ✓ The Board of Directors meeting to approve the draft fiscal year 2020 budget is scheduled for April 14, 2021;
- ✓ The 2020 Financial Results Presentation to Analysts and Investors, originally scheduled for March 29, is postponed to April 15, 2021;
- ✓ The Annual Shareholders Meeting to approve the financial statements for the year ended December 31, 2020, originally scheduled for April 28, 2021, is postponed to May 14, 2021;
