UNIDATA SECURES THREE CONTRACTS FOR THE IMPLEMENTATION AND MANAGEMENT OF IOT SMART METERING SYSTEMS FOR WATER DISTRIBUTION IN THE EMILIA-ROMAGNA AND TUSCANY REGIONS

PROJECTS AIM TO DIGITISE WATER DISTRIBUTION NETWORKS AND IMPROVE SYSTEM EFFICIENCY TO REDUCE WATER LOSS

Unidata has secured three contracts worth approximately €1 million for the design, implementation, and management of remote reading networks based on LoRaWan® technology

Roma, 10 March 2025 – Unidata S.p.A. (UD.MI), operator of telecommunications, cloud and IoT services, listed on Euronext Milan – STAR Segment, organized and managed by Borsa Italiana S.p.A., has been awarded three contracts by SorgeAqua S.r.I., ASA S.p.A., and Municipality of Zeri for the design, implementation, and management of remote water metering networks based on LoRaWan® technology. These projects address the need to reduce water loss, digitise, and monitor water distribution networks.

Specifically, Unidata has been awarded the contract from SorgeAqua S.r.l. as part of a temporary business consortium (RTI) that includes IDEA S.r.l., IDEA Telecontrollo S.r.l., Idragest S.r.l., Easy Servizi S.r.l., Datek 22, Idrostudi S.r.l., So.Sel S.p.A., and Consorzio Innova Società Cooperativa. Similarly, the contract granted by the Municipality of Zeri was secured through an RTI involving Unidata, Geomar S.r.l., and Idrostudi S.r.l.

The total value of the three contracts assigned to Unidata, amounting to approximately €1 million, includes the design and implementation of the IoT LoRaWan® network in the water distribution systems of Livorno, managed by ASA S.p.A., the Municipality of Zeri in Tuscany, and the municipalities managed by SorgeAqua S.r.I. in the Emilia-Romagna Region.

Patrizio Pisani, Head of Innovation and Research at Unidata, commented: "We are very pleased with these new contracts, which reaffirm Unidata's role as a strategic partner in the digital transformation of water infrastructure. Thanks to our expertise in IoT networks and LoRaWan® technology, we will help make water distribution networks more efficient and sustainable, reducing losses and enhancing monitoring. These
