# THE DIGITAL FUTURE PASSES THROUGH MAZARA DEL VALLO: TODAY ON THE COAST, THE LAYING OF THE UNITIRRENO SUBMARINE OPTICAL FIBER CABLE

An opportunity for Sicily and a strategic infrastructure that strengthens Italy's connectivity and its centrality in the Mediterranean sea

Roma, 29 April 2025 – On today's date, in Mazara del Vallo, the laying of the fiber optic cable of the Unitirreno submarine system, a digital infrastructure of strategic importance that will connect Sicily to Liguria (Genoa) passing through Olbia and Rome-Fiumicino, making these locations crucial hubs of the Mediterranean sea, took place.

The section of the cable just laid in Mazara del Vallo, carried from the beach towards the open sea, represents a crucial piece of a broad process of digital transformation and evolution. Built by Unitirreno – a joint venture composed by Unidata S.p.A. and the ESG Growth Infrastructure Fund (IPC) managed by Azimut Libera Impresa SGR S.p.A. – the project aims to **position Italy at the center of global telecommunications networks**.

The submarine cable, which will extend for over 1,030 kilometers, represents the **first Open Cable system in the Mediterranean basin with 24 pairs of optical fibers**; it will guarantee cutting-edge, reliable and secure technology, capable of guaranteeing high-level performance and offering a new secure and lowlatency route for data transit between Europe, Africa and the Middle East.

# A strategic opportunity for Sicily

The choice of Mazara del Vallo as the cable's landing point reflects a broader vision: that of **Sicily as a protagonist of the country's digital transition**. The island is indeed consolidating its role as a technological and connective hub in the Mediterranean, also thanks to infrastructural investments and a growing focus on the digital development of the territory. **Sicily Region** has activated **over 350 digital facilitation points** to improve citizens' skills, is promoting the **digitalization of public administration** and has launched **programs to strengthen the adoption of cloud and BIM** (Building Information Modeling) **in public works**. Initiatives that are supported by a regional strategy of smart specialization (S3) oriented towards innovation, ecological transition and the valorization of human capital.

In this context, the **Unitirreno system** fits in as an **enabling infrastructure to attract investments** in the cloud, data center and digital services sectors, making Sicily an advanced interconnection platform.

In an ever-changing geopolitical context, this infrastructure marks a key moment in the consolidation of Italy as a reference point for telecommunications in the Mediterranean sea, strengthening its presence in global digital dynamics. This investment not only enhances Italian technological innovation, but contributes to building an increasingly connected, resilient and competitive future.
