UNIDATA IS AWARDED IN TEMPORARY GROUPING OF COMPANIES AND SIGNS THE CONCESSION AGREEMENT FOR THE IMPLEMENTATION AND MANAGEMENT OF AN IOT SMART WATER METERING SYSTEM FOR THE MOLISE REGION

THE PROJECT FALLS WITHIN THE IOT SCOPE FOR CORRECT MONITORING OF CONSUMPTION, PREPARATION OF THE WATER BALANCE, IDENTIFICATION OF LOSSES AND REDUCTION OF WASTE

The total assignment to the Temporary Grouping of Companies is equal to 49 million Euros, with a share allocated to Unidata of over 3 million Euros for a duration of approximately 2 years. Unidata will collaborate in the design and implementation of the remote reading network based on LoRaWan® technology and the TLC WAN network.

Roma, 15 January 2024 – Unidata S.p.A. (UD.MI), operator of telecommunications, cloud and IoT services, listed on Euronext Milan – STAR Segment, organized and managed by Borsa Italiana S.p.A., announces that it has been awarded in Temporary Grouping of Companies and that it has signed the contract for the assignment by G.R.I.M. (Water Resources Management of Molise) of the contract for the “Interventions aimed at reducing losses in water distribution networks, including digitalisation and monitoring of the networks”. The intervention is based on the resources of the NRRP for the “protection and enhancement of the territory and water resources through sustainable management of water resources and the reduction of losses in water distribution networks”.

The awardee Temporary Grouping of Companies, which in addition to Unidata sees the participation of Information Development and Automation S.r.l., Atena Sintec S.r.l., Datek22 S.r.l., Acea Elabori S.p.A., Pide S.r.l., Idragest S.r.l., IA.ING S.r.l., A2A Smart City S.p.A., Beccaceci S.r.l., will be engaged in a complex engineering project that includes the digitalization of the water network, the installation of smart tools for network measurements, hydraulic modelling, the districting of the network and active leak control, as well as the creation of the LoraWAN® remote reading network and the supply of digital smart meters for measuring user consumption.

The total value of the award intended for Unidata, which amounts to over 3 million Euros, includes, in collaboration with other partners of the Temporary Grouping of Companies, the following activities:

- design and implementation of the LoRaWan® IoT network for all municipalities in the Molise Region;
- design of WAN and WiFi telecommunications networks.

Patrizio Pisani, Head of Innovation and Research at Unidata, commented: “We are very satisfied with this further concession in the IoT field which consolidates our role among the leaders of digital infrastructures and sees us as an active part of a synergical collaboration with other companies, national excellences, who collaborate to realize innovative ambitions of Molise. The project promoted by G.R.I.M. falls within the scope of the economic recovery and relaunch policies envisaged by the NRRP, an opportunity that the Region has



been able to seize with the establishment of this tender to promote innovative activities for the territory, enhance a vital resource such as water and stimulate industrial growth".
